Agree(s) to release, waive, indemnify, hold harmless and release from any and all liability to Atlanta Diving Association, Inc its administrators, directors, officers, shareholders, coaches, and representatives(hereinafter referred to as the releasees) from any and all present or future claims, rights, demands, damages, causes of action and/or liability of every nature and kind whatsoever which the undersigned may have against the releasees of claims caused or alleged to be cause in whole or in part of the actions, inactions or negligent of the releasees.
